With the signing of this contract, the Purchaser/s acknowledge that they have read this contract in its entirety and agree to abide by all stipulations contained herein:

The above purchaser/s acknowledge the stud fee for this stallion during the year _____ is \$_____, which is nonrefundable. Purchaser/s are aware that all semen shipped is to be used for the above named mare only and no others. Any attempt to use any portion of semen shipped to Purchaser/s to breed any mare other than the designated mare named in this contract shall automatically terminate all obligations of the Stallion Owners and Luahana Arabians, including but not limited to any live-foal guarantee, rights to additional semen, rebreeding rights, and the responsibility to register any offspring produced by the use of the semen, including the original intended foal. All of the Purchaser/s rights provided by this breeding contract/Agreement shall be forfeited and the Purchaser/s shall be liable for the amount up to the cost of breeding for every unapproved mare inseminated whether a foal is produced or not, and legal relief will be sought by the Stallion Owner/s and Luahana Arabians for all violations. This contract shall not be assigned or transferred without the written consent of Stallion Owner or Luahana Arabians.

Lab fee is \$200.00 per collection plus all Fed Ex fees or other shipping fees, which is nonrefundable. If the mare owner can arrange to pick up semen then the Fed Ex fees will be waived and only the \$200.00 lab fee per collection will apply. The deposit on the shipping container is \$200.00 which is refundable after the last shipment of semen to mare. Semen containers must be returned within 3 days or a penalty will result in a penalty charge of \$25.00 per day. All fees, deposits and costs must be paid before semen will be collected and shipped.

Collection days are Monday-Thursday, unless mare owner can receive a Saturday Fed Ex delivery, then semen will be collected and shipped on Friday. Stallion owner requires 24 hour notice for collection and should be notified by 9:00 AM PST, advance notice is always appreciated. Same Day shipping **may** be given in an emergency.

Credit Cards are excepted for online payment utilizing Paypal a very secure service.

The mare owner is responsible for all veterinarian charges related to insemination and the pregnancy of the mare, it is recommended that the mare be checked in foal at 20 days and a recheck at 45 days to confirm pregnancy. The mare owner shall assume all responsibility for the condition of the mare and shall bear all risks of loss or damage to the mare and therefore agrees to hold the Stallion Owner or Luahana Arabians harmless for any and all damages. Stallion owner or Luahana Arabians assumes responsibility only to deliver live semen in viable condition at the time of delivery to the designated veterinarian or Technician. To insure Purchaser/s "LIVE FOAL GUARANTEE" and assurance of a rebreed for said mare/s or a substitute the following year if necessary, Luahana Arabians staff must be kept current on the mare/s continuing condition after declared in foal, and also when the mare foals and condition of the foal at birth.

It is further understood that should the above named stallion die or become unfit for service prior to the first breeding, the mare owner may select any other stallion currently standing at Luahana Arabians.
